

## Empanelled Hospital list in respect of ICAR-NINFET, Kolkata

### GUIDELINES FOR IPD & OPD TREATMENT OF EMPANELLED HOSPITAL OF ICAR-NINFET

1. Regular employees and their dependents are eligible for both IPD & OPD treatment, whereas pensioner and their dependents are entitled for IPD treatment only.
2. For IPD planned treatment, admission should be done on the basis of referral of Institute AMA/other nearby ICAR Institute's AMA/CGHS empanelled AMA and on production of valid medical card.
3. In emergency conditions, where immediate medical attention is needed admission should be rendered on production of valid medical card. The hospital is required to issue an emergency certificate in that case.
4. The medical card is issued to the employee, pensioner and their dependents on the basis of their present family declaration only. All are requested to review the matter periodically and in case of revision in family/change of dependence on govt. servant, the medical card needs to be submitted to the issuing authority immediately, failing of which the govt. service is liable to come under disciplinary action.

Sl. No.	Definition	Clarification
1.	Unmarried son/Step son	Till he starts earning (Rs. 9000/- as basic), or attains the age of 25 years, whichever is earlier.
2.	Daughter	Till she starts earning (Rs. 9000/- as basic) or gets married, whichever is earlier, irrespective of age-limit
3.	Son suffering from permanent disability of any kind (Physical or mental):	No age-limit
4.	Widowed daughters and dependent divorced/judicially separated daughters with income below Rs. 9000/- as basic	Irrespective of age-limit
5.	Sister including unmarried /divorced/abandoned or judicially separated from husband/widowed sisters	Irrespective of age-limit.
6.	Parents/ Step Parents / Parents in Law	Fully dependent and earning below Rs. 9000/- as basic (claim for either parents or in-laws)
7.	Dependency on the basis of income	The income limit for dependency of the family members (other than spouse) is ₹9000 plus the amount of Dearness Relief admissible on ₹9000 on the date of consideration of the claim
8.	Both husband and wife are employed in a State Government, Defence/Railways or Corporation/Bodies financed partly/wholly by the Central/State Government, local bodies and private organizations	Either of the spouse may choose to avail the medical facilities under central government rules or facilities provided by the organisation in which the spouse is employed. In either case a certificate to be furnished that the facilities are availed from only one source.
9.	Husband & wife both are central government servant	Prefer claim for self and eligible members of their family, (either of the spouse) according to his/her status.
