<u>कार्यालय आदेश/OFFICE ORDER</u>

In the light of inordinate dislocation of available resources and limited infrastructure of this Institute, the Director, ICAR-NINFET has decided the following modifications related to implementation of cashless treatment of empanelled hospitals for employees, pensioners and their dependants

- (a) Henceforth, only those non-NINFET pensioners would be considered to be enlisted for obtaining cashless medical facilities by this Institute whose last address of settlement is nearest to this Institute compared to other Institutes and who have preferred such request through their parent Institute only.
- (b) Non-NINFET pensioners, who have retired prior to January, 2022 shall not be considered for enlistment for medical purposes from this Institute. However, the matters can be examined at the Institute level on case-to case basis and suitable cases can be considered with the approval of the Competent Authority.
- (c) The validity of the medical identity cards shall be fixed for 3 (three) years which will be implemented from henceforth.
- (d) The planned treatment mandatorily requires referral from Institute Medical Officer for treatment in empaneled hospital except for emergency admission, which warrants suitable certificate issued by the hospital.
- (e) The pensioners are liable to return the medical card to the Institute, if any of the dependent criteria of self/dependents fails to meet the requisite criteria, failing which suitable administrative action will be taken against the concerned.

This is being issued with the approval of the Director, ICAR NINFET.
